Any change in reporting requirements would require a rule change.

Staff presented to the Board the letter submitted by SEBA regarding West Virginia's State Installation Program Review. An initial response drafted by Ms. Farber was approved, with some additions. Further discussion will take place at the next scheduled board meeting.
