The West Virginia Board of Manufactured Housing Construction and Safety met March 30, 2022, via teleconference at 1900 Kanawha Boulevard East, State Capitol Complex - Building 3, Room 200 - Charleston, West Virginia at 10:00 a.m.

MEETING CALLED TO ORDER

A quorum being present, Mr. Woodrum called the meeting to order at 10:01 a.m.

APPROVAL OF AGENDA

Mr. Gunnell made a motion to approve the agenda. Mr. Shaw seconded. Motion carried.

APPROVAL OF MINUTES

Approval of the December 8, 2021, board meeting minutes.

Mr. Shaw made a motion to approve the minutes. Mr. Solomon seconded. Motion carried.

PUBLIC COMMENT

No one appeared for public comment.

DISCIPLINARY HEARINGS

The hearings are for licensees that failed to protest violation issued within ten (10) days from receipt of violation or protested violation and was denied, and the Board will hear evidence pertaining to fines and/or penalties on those violations.

22-DISC-001 – CMH Manufacturing, Inc. DBA Clayton-Rockwell – WV00952. Violated §42-CSR-19-14.1(u) – Failure to fulfill any written or implied warranty.

No one appeared on behalf of Clayton-Rockwell.

Mr. White presented evidence and recommended a \$250.00 fine for failing to fulfill warranty obligations and an order to complete corrections within fifteen (15) days from receipt of final order or license will be suspended.

Mr. Solomon made a motion to amend staff recommendation to **\$500.00**. Mr. Shaw seconded. Motion carried, with the Chair voting.

22-DISC-002 – **Pinewood Mobile Home Sales, Inc.** – **WV00009.** Violated §42-CSR-19-10A.2(a)(i) and §42-CSR-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard; and §42-CSR-19-14.1(s) – Utilization of an unlicensed contractor.

Shawn Groves appeared on behalf of Pinewood Mobile Home Sales, Inc.

Mr. White presented evidence and recommended a \$200.00 fine for failing to install a manufactured home in compliance with a state or federal standard and \$250.00 fine for utilizing an unlicensed contractor.

Mr. Shaw made a motion to amend staff recommendation for utilizing an unlicensed contractor to a **Reprimand** and accept recommendation of \$200.00 for installation. Mr. Solomon seconded. Motion carried, with the Chair voting.

22-DISC-003 – CMH Manufacturing, Inc. DBA Clayton-Bean Station – WV00118. Violated §42-CSR-19-14.1(u) – Failure to fulfill any written or implied warranty.

No one appeared on behalf of Clayton-Bean Station.

Mr. White presented evidence and recommended a **\$500.00 fine for failing to fulfill warranty obligations.**

Mr. Solomon made a motion to accept staff recommendation. Mr. Shaw seconded. Motion carried, with the Chair voting.

22-DISC-004 – **CMH Homes, Inc. DBA Clayton Homes #1028** – **WV01165**. Violated §42-CSR-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard.

No one appeared on behalf of Clayton Homes #1028.

Mr. White presented evidence and recommended a \$500.00 for failing to install a manufactured home in compliance with a state or federal standard and an order to complete corrections within fifteen (15) days from receipt of final order or license will be suspended.

Mr. Casto made a motion to accept staff recommendations. Mr. Shaw seconded. Motion carried, with the Chair voting. Mr. Gunnell recused himself.

22-DISC-005 – **Cana MH, LLC** – **WV01272.** Violated §42-CSR-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard; and §42-CSR-19-14.1(d) – Failure to establish and maintain records.

No one appeared on behalf of Cana MH, LLC.

Mr. White presented evidence and recommended a \$200.00 fine for failure to install a manufactured home in compliance with a state or federal standard and an order to complete corrections within fifteen (15) days from receipt of final order or license will be suspended; and \$200.00 fine for failing to establish and maintain records.

Mr. Solomon made a motion to accept staff recommendations. Mr. Casto seconded. Motion carried, with the Chair voting.

22-DISC-006 – CMH Homes, Inc. DBA Clayton Homes #1028 – WV01165. Violated §42-CSR-19-14.1(d) – Failure to establish and maintain records.

No one appeared on behalf of Clayton Homes #1028.

Mr. White presented evidence and recommended a \$200.00 fine for failing to establish and maintain records.

Mr. Casto made a motion to accept staff recommendation. Mr. Solomon seconded. Motion carried, with the Chair voting. Mr. Gunnell recused himself.

22-DISC-007 – **CMH Homes, Inc. DBA Clayton Homes #1028** – WV01165. Violated §42-CSR-19-14.1(d) – Failure to establish and maintain records; §42-CSR-19-10A.3 -Frostline considerations; §42-CSR-19-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard; and §42-CSR-19-14.1(s) – Utilization of an unlicensed contractor.

No one appeared on behalf of Clayton Homes #1028.

Mr. White presented evidence and recommended a **Reprimand for failing to establish and maintain** records; \$750 fine for frostline considerations; \$250.00 for failing to install a manufactured home in compliance with a state or federal standard and an order to complete corrections within fifteen (15) days from receipt of final order or license will be suspended; and \$250.00 fine for utilizing an unlicensed contractor.

Mr. Solomon made a motion to accept staff recommendation. Mr. Casto seconded. Motion carried, with the Chair voting. Mr. Gunnell recused himself.
