## **MEETING CALLED TO ORDER**

A quorum being present, Mr. Woodrum called the meeting to order at 10:00 a.m.

## APPROVAL OF AGENDA

Mr. Solomon made a motion to approve the agenda. Mr. Shaw seconded. Motion carried.

#### **APPROVAL OF MINUTES**

Approval of the September 28, 2023, board meeting minutes.

Mr. Gunnell made a motion to approve the minutes. Mr. Belasco seconded. Motion carried.

#### **PUBLIC COMMENT**

No one appeared for public comment.

#### **DISCIPLINARY HEARINGS**

The hearings are for licensees that failed to protest violation issued within ten (10) days from receipt of violation or protested violation and was denied, and the Board will hear evidence pertaining to fines and/or penalties on those violations.

**24-DISC-001 – S & M Used Automobile & Mobile Home Sales, Inc. DBA S & M Mobile Home Sales – WV00831.** Violated §42-CSR-19-10A.2(a)(i) and §42-CSR-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard; and §42-CSR-19-14.1.4 – Failure to establish and maintain records.

No one appeared on behalf of S & M Mobile Home Sales.

Mr. White presented evidence and recommended a \$250.00 fine for failing to install a manufactured home in compliance with a state or federal standard and an order to correct within fifteen (15) days from receipt of final order. Failure to correct within the time specified will result in the suspension of License WV00831 until such time all corrections are completed and a \$400.00 fine for failing to establish and maintain records.

Mr. Solomon made a motion to change the staff's recommendation of \$400.00 for records to \$750.00 and accept the remaining recommendation. Mr. Shaw seconded. Motion carried.

**24-DISC-002** – Adventure Homes, LLC – WV01257. Violated §42-CSR-19-14.1.21 – Failure to fulfill any written or implied warranty.

No one appeared on behalf of Adventure Homes, but a written response was submitted.

Mr. White presented evidence and recommended a **\$250.00 fine for failing to fulfill warranty obligations.** 

Mr. Solomon made a motion to accept the staff's recommendation. Mr. Casto seconded. Motion carried. Mr. Gunnell recused himself.

**24-DISC-003 – CMH Homes, Inc. DBA Clayton Homes #1024 – WV01161**. Violated §42-CSR-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard.

No one appeared on behalf of Clayton Homes #1024.

Mr. White presented evidence and recommended a \$500.00 fine for failing to install a manufactured home in compliance with a state or federal standard and an order to correct within fifteen (15) days from receipt of final order. Failure to correct within the time specified will result in the suspension of License WV01161 until such time all corrections are completed.

Mr. Solomon made a motion to accept the staff's recommendation. Mr. Belasco seconded. Motion carried. Mr. Gunnell recused himself.

**24-DISC-004 – CMH Homes, Inc. DBA Clayton Homes #1024 – WV01161**. Violated §42-CSR-10A.2(a)(i) and §42-CSR-19-14.1(o) – Failure to install a manufactured home in compliance with a state or federal standard; §42-CSR-19-12.1 – Failure to transport a manufactured home in accordance with a state or federal standard; and §42-CSR-19-14.1.4 – Failure to establish and maintain records.

No one appeared on behalf of Clayton Homes #1024.

Mr. White presented evidence and recommended a **\$200.00 fine** for failing to install a manufactured home in compliance with a state or federal; a **Reprimand** for failing to transport a manufactured home in accordance with a state or federal standard; and a **\$200.00 fine** for failing to establish and maintain records.

Mr. Shaw made a motion to accept the staff's recommendations. Mr. Solomon seconded. Motion carried. Mr. Gunnell recused himself.

Adam Cantoni appeared at the request of the Board via telephone.

The Board discussed the company's issues regarding records violations and delays in making repairs ordered by the Board. Mr. Cantoni assured the Board that there will be no issues in the future.
